PROKUM WAXED BLOCKS

plastic bags x 100 g; - boxes x 400 g sacks x 5 kg and 10 kg -

ACTIVE SUBSTANCE:

0,005% Brodifacoum CAS No. 56073-10-0 CE No. 259-980-5 - anticoagulant on support of ground paraffined wheat.

The product contains BITREX.

Specific antidote: Vitamin K1.

INDICATIONS:

For controlling mice and rat infestations inside where is a high rate of humidity, houses, stables and farm buildings, gardens, landfills, barracks, warehouses, wagons, containers, etc., including open spaces, gardens, seweges, river banks, garbage storing places. It can be places on wet surfaces, where other raticides can not be used. Brodifacoum works by blocking the synthesis of prothrombin and capillary wall patency. Death occurs in 3-6 days after ingesting the bait. The grain is heat treated to combat grain weevils.

INSTRUCTONS AND RECOMMENDED DOSES:

Place the block baits in the active gallerys and places attended by mice and rats. Place the blocks in bait stations. For fighting rat, place 1-3 block at distances of 10 meters (5 m for severe infestation), in case of mice place 1 block at distances of 5 meters (2 meters for severe infestations). Verify and replace the consumated bait regularly, until the consumption stops. Repeat the treatment in case of a new infestation. If every bait is eaten, increase the bait quantity, by placeing in more bait spots. Do not increase the quantity in one spot.
